## RANGE STANDING ORDERS

1. CHRISTCHURCH PISTOL CLUB INC
2. Range Name: Burnett Range
3. Dated: 18<sup>th</sup> April 2024

Range Standing Orders (RSOs) are written to ensure all Club Members and users are aware of the conditions that apply to these ranges.

Safety **MUST** be your prime consideration when using the Christchurch Pistol Club Inc. Club Ranges.

All persons not involved in the match being shot are to remain at least **1m** behind the shooting line or starting position and must remain quiet so as not to interfere with the giving of instructions by any Range Officers

### 4. INTRODUCTION:

- The Christchurch Pistol Club Inc. is sited at 599 McLeans Island Road, Christchurch, 8051.
- The Christchurch Pistol Club Inc. is the Shooting Range Operator (SRO) of these ranges.
- Land owner is Ecan.
- The range is situated within in an area with the Legal Description: Lot 1 DP 28931 739837 599 McLeans Island Road.
- All ranges are certified as a **No Danger Area Range (NDA)**.
- These RSOs are applicable to **ALL PERSONS** who enter the property operated by the Christchurch Pistol Club Inc.
- These orders are to be promulgated to all Christchurch Pistol Club members and all other user organisations.
- A Copy of these RSOs is to be permanently displayed on the club notice board.
- **Hours of operation** are 24 Hours a day seven days a week.
- **RANGE REGISTER**; Every person who enters the Christchurch Pistol Club range complex is to sign the register upon arrival. Members, via electronic card scan, and **all visitors** to sign the Range Register situated inside the entrance door of the Air Range building.
- The signing of the range register acknowledges that the user has read, understood and accepted the RSOs and the specific Pistol Discipline rules or specified Rifle or Shotgun or Black Powder rules posted on the range.
- All users are to read these standing orders.
- Access and use of these ranges is for Christchurch Pistol Club Members, Associate Members and visitors under direct control of an Officer on Duty (OD)/Range Officer (RO).
- All pistol shooters must either hold a B endorsement on their firearms licence or be under the direct supervision of a holder of a firearms licence with a B endorsement. All non firearms licence holders must be under the direct supervision of the holder of a firearms licence.

- Firearms may only be handled at this range complex under the following circumstances. [a] In the designated and approved Safety Zone or designated loading & unloading tables.  
[b] On the range under the supervision of a RO or other approved match official.

## 5. Responsibility:

- The SRO is the Christchurch Pistol Club Inc.
- The Christchurch Pistol Club Inc. management committee is responsible for the administration, allocation, and ongoing maintenance of all ranges, and are also responsible for ensuring that all members are familiar with and abide by these RSOs.

## 6. Compliance with Range Standing Orders (RSOs):

- All users of the range are subject to these RSOs.
- User organisations permitted use of these facilities will have their approval withdrawn if they do not adhere to these RSOs.

## 7. Location:

- The range complex is located at Topo 50 Map No. **BX23 Lincoln**.
- NZTM Reference: **E1559641 N5186993**.
- **Address: 599 McLeans Island Road, Christchurch, 8051.**

## 8. Approved Range Users and Priority of Use:

- The following is the order of priority for the use of the Christchurch Pistol Club range and no other individual may use the range unless they are fully authorised members of one of the associations listed below.

[a] Christchurch Pistol Club Incorporated members,

[b] Members of Pistol NZ,

[c] Other users approved by Christchurch Pistol Club Committee.

- The range is not to be allocated for use by non-members or non-affiliated organisations without the express authority of the committee of the Christchurch Pistol Club Inc.

## 9. Warning Flags-Danger Signs:

- Minimum main flag size is 1200mm x 600mm.
  - Range Danger Flags and warning signs are to be enabled at the following locations prior to commencement of any firing.
    - [a] Main Flag Pole. NZTM Grid Reference **E1559696 N5186928**.
    - [b] Entrance to ranges 1 – 4.
    - [c] Ranges 5 - 9 Range Shelters.
    - [d] Warning signs are to be maintained at regular intervals along the range Boundary.
- The warning flags must be lowered, when the range is closed.

**10. Description of individual ranges and Conditions of use:**

- The complex has Ten (10) ranges.
- **Approved shooting activities** are any discipline that falls under the disciplines provided through Pistol NZ
- **The ranges are restricted to the firing of the following firearms:**

**➤ Range 1: 25m Outdoor No Danger Area Range.****Restrictions:**

- a) Pistols up to and including .45 calibre with a muzzle velocity no greater than 1600fps. b) Rifles firing pistol calibres up to and including .45 calibre with a muzzle velocity no greater than 655m/s (2148fps).
- c) Rifles up to and including .22Rimfire with a muzzle velocity no greater than 1600fps.
- d) Black powder pistols up to and including .58 calibre with a muzzle velocity no greater than 655m/s (2148fps).

**Conditions of Use: Range 1:**

- Targets may only be placed on the target frames under the eyebrow.
- All shooting is to take place from the 25-metre firing line unless it is a club organized event.
- In a club organized event shooting can take place between the 15 to 7 metre firing lines. • Hand guns are not to be loaded in a holster unless in a club organized event.

**➤ Range 2: 25m Outdoor No Danger Area Range.****Restrictions:**

- a) Pistols up to and including .45 calibre with a muzzle velocity no greater than 1600fps. b) Rifles firing pistol calibres up to and including .45 calibre with a muzzle velocity no greater than 655m/s (2148fps).
- c) Rifles up to and including .22Rimfire with a muzzle velocity no greater than 1600 fps.
- d) Black powder pistols up to and including .58 calibre with a muzzle velocity no greater than 655m/s (2148fps).

**Conditions of Use: Range 2:**

- Targets may only be placed on the target frames under the eyebrow.
- All shooting is to take place from the 25-metre firing line unless it is a club organized event.
- In a club organized event shooting can take place between the 15 to 7 metre firing lines. • Hand guns are not to be loaded in a holster unless in a club organized event.

**➤ Range 3: 25m Outdoor No Danger Area Range.****Restrictions:**

- a) Pistols up to and including .45 calibre with a muzzle velocity no greater than 1600fps. b) Rifles firing pistol calibres up to and including .45 calibre with a muzzle velocity no greater than 655m/s (2148fps).

- c) Rifles up to and including .22Rimfire with a muzzle velocity no greater than 1600fps.
- d) Black powder pistols up to and including .58 calibre with a muzzle velocity no greater than 655m/s (2148fps).

**Conditions of Use: Range 3:**

- Targets may only be placed on the target frames under the eyebrow. • All shooting is to take place from the 25-metre firing line unless it is a club organized event.
- In a club organized event shooting can take place between the 15 to 7 metre firing lines. • Hand guns are not to be loaded in a holster unless in a club organized event.

➤ **Range 4: 25m Outdoor No Danger Area Range.**

**Restrictions:**

- a) Pistols up to and including .45 calibre with a muzzle velocity no greater than 1600fps. b) Rifles firing pistol calibres up to and including .45 calibre with a muzzle velocity no greater than 655m/s (2148fps).
- c) Rifles up to and including .22Rimfire with a muzzle velocity no greater than 1600 fps.
- d) Black powder pistols up to and including .58 calibre with a muzzle velocity no greater than 655m/s (2148fps).

**Conditions of Use: Range 4:**

- Targets may only be placed on the target frames under the eyebrow. • All shooting is to take place from the 25-metre firing line unless it is a club organized event.
- In a club organized event shooting can take place between the 15 to 7 metre firing lines. • Hand guns are not to be loaded in a holster unless in a club organized event.

➤ **Range 5: 25m Outdoor No Danger Area Range.**

**Restrictions:**

- a) Pistols and pistol carbine up to and including .45 calibre with a muzzle velocity no greater than 1600fps.
- b) Rifles firing pistol calibres up to and including .45 calibre with a muzzle velocity no greater than 655m/s (2148fps).
- c) Rifles up to and including .22Rimfire with a muzzle velocity no greater than 1600 fps.
- d) Black powder pistols up to and including .58 calibre with a muzzle velocity no greater than 655m/s (2148fps).
- e) Shotguns up to and including 12 gauge with a muzzle velocity no greater than 1600fps.

**Conditions of Use: Range 5:**

- Targets may, subject to these range standing orders be placed at ranges from 25 metres to 1 metre from the firing line.
- Shooting into Left and right-side backstops permitted.
- Shotgun must be shot with number 5 shot or smaller.
  - Steel targets must be fully shrouded and no closer than 7 metres from the firing line.

**➤ Range 6: 25m Outdoor No Danger Area Range.****Restrictions:**

- a) Pistols and pistol carbine up to and including .45 calibre with a muzzle velocity no greater than 1600fps.
- b) Rifles firing pistol calibres up to and including .45 calibre with a muzzle velocity no greater than 655m/s (2148fps).
- c) Rifles up to and including .22Rimfire with a muzzle velocity no greater than 1600 fps.
- d) Black powder pistols up to and including .58 calibre with a muzzle velocity no greater than 655m/s (2148fps).
- e) Shotguns up to and including 12 gauge with a muzzle velocity no greater than 1600fps.

**Conditions of Use: Range 6:**

- Targets may, subject to these range standing orders be placed at ranges from 25 metres to 1 metre from the defined firing line.
- Steel targets must be placed under the eyebrow or be fully shrouded and no closer than 7 metres from the defined firing line.
- Shooting into Left and right-side backstops permitted.
- Shotgun must be shot with number 5 shot or smaller.

**➤ Range 7: 25m Outdoor No Danger Area Range.****Restrictions:**

- a) Pistols and pistol carbine up to and including .45 calibre with a muzzle velocity no greater than 1600fps.
- b) Rifles firing pistol calibres up to and including .45 calibre with a muzzle velocity no greater than 655m/s (2148fps).
- c) Rifles up to and including .22Rimfire with a muzzle velocity no greater than 1600 fps.
- d) Black powder pistols up to and including .58 calibre with a muzzle velocity no greater than 655m/s (2148fps).
- e) Shotguns up to and including 12 gauge with a muzzle velocity no greater than 1600fps.

**Conditions of Use: Range 7:**

- Targets may, subject to these range standing orders be placed at ranges from 25 metres to 1 metre from the defined firing line.
- Steel targets must be fully shrouded and no closer than 7 metres from the defined firing line.
- Shooting into Left and right-side backstops permitted.
- Shotgun must be shot with number 5 shot or smaller.

**➤ Range 8: 25m Outdoor No Danger Area Range.****Restrictions:**

- a) Pistols and pistol carbine up to and including .45 calibre with a muzzle velocity no greater

than 1600fps.

- b) Rifles firing pistol calibres up to and including .45 calibre with a muzzle velocity no greater than 655m/s (2148fps).
- c) Rifles up to and including .22Rimfire with a muzzle velocity no greater than 1600 fps.
- d) Black powder pistols up to and including .58 calibre with a muzzle velocity no greater than 655m/s (2148fps).
- e) Shotguns up to and including 12 gauge with a muzzle velocity no greater than 1600fps.

### **Conditions of Use: Range 8:**

- Targets may, subject to these range standing orders be placed at ranges from 25 metres to 1 metre from the defined firing line.
- Steel targets must be fully shrouded and no closer than 7 metres from the defined firing line.
- Shooting into Left and right-side backstops permitted.
- Shotgun must be shot with number 5 shot or smaller.

### **➤ Range 9: 25m Outdoor No Danger Area Range.**

#### **Restrictions:**

- a) Pistols and pistol carbine up to and including .45 calibre with a muzzle velocity no greater than 1600fps.
- b) Rifles firing pistol calibres up to and including .45 calibre with a muzzle velocity no greater than 655m/s (2148fps).
- c) Rifles up to and including .22Rimfire with a muzzle velocity no greater than 1600 fps.
- d) Black powder pistols up to and including .58 calibre with a muzzle velocity no greater than 655m/s (2148fps).
- e) Shotguns up to and including 12 gauge with a muzzle velocity no greater than 1600fps.

### **Conditions of Use: Range 9:**

- Targets may subject to these range standing orders be placed at ranges from 25 metres to 1 metre from the defined firing line.
- Steel targets must be placed under the eyebrow or be fully shrouded and no closer than 7 metres from the firing line.
- Shooting into Left and right-side backstops permitted.
- Shotgun must be shot with number 5 shot or smaller.

### **➤ Range 10: 10m Indoor No Danger Area Range.**

#### **Restrictions:**

- a) Club approved air Pistols up to and including .177 calibre.
- b) Club approved air Rifles up to and including .177 calibre.

### **Conditions of Use: Range 10:**

- A 10-metre fixed firing position range for air pistols and air rifles only. • Targets may only be placed at the 10-metre target line. (10 electronic targets and 2 standard targets).

- Shooting may only take place from the 10-metre firing line except for specific training courses when variable firing distances inside 10 metres may be used.
- Max energy for air rifles and pistols limited to 7.5 joules.
- Only flat nose lead pellets to be used.

### **11. Range safety roles:**

- An Officer on Duty/Range Officer. (RO) must be on duty whenever the range is in use. The RO shall be:
  1. A qualified person approved by the Christchurch Pistol Club Committee, shall hold a firearms licence, and be appropriately trained in shooting range safety management and the shooting discipline being undertaking.
  2. If an individual is shooting solo on the range, they must be a qualified RO. 3. Any other qualified safety officer may be appointed as required by match rules.

### **12. Range safety rules:**

- Safety of the range is the responsibility of all range users.
- The RO is responsible for ensuring that the range is safe for use prior to the commencement of any shooting activity
- That the bullet catcher is in good repair.
- That only approved or authorised targets are used on the range.
- Ammunition restrictions are adhered to.
- That there is no person(s) or activity in the danger area.
- That hearing & eye protection is used by all range users and spectators. • The safety rules for individual shooting disciplines are to be complied with in conjunction with these RSOs. Where individual safety rules may contradict these RSOs, the RSOs are to take precedence. Club executives are to seek a satisfactory and safe resolution to eliminate this situation and where necessary amend RSOs.

### **THE FOLLOWING SAFETY RULES ARE EMPHASISED.**

- No person shall refuse to obey the lawful instructions of the RO or any other official acting in the proper function of the affairs of their office.
- No person shall enter or leave the range with a loaded firearm.
- No firearm shall be loaded until the shooter is on the firing line and the command "LOAD" has been given by the RO.
- When not at the firing line, firearms will be unloaded at all times. Special conditions apply to holster qualified members while involved in action and practical match shooting. • All Visitors must be accompanied by a member of the Christchurch Pistol Club while shooting on the ranges.
- No person on the firing line shall handle a firearm while any other person is forward of the



firing line.

- The RO must ensure shooters guns are cleared before declaring the range "CLEAR".
- A club membership or visitor ID/card must be carried at all times and presented upon request of any club member.
- No alcohol or drugs are to be consumed prior to, or during shooting. Any person consuming alcohol, or under the effect of alcohol or drugs while shooting will immediately be expelled from the range, and the matter followed up with regards to further disciplinary action if deemed appropriate.
- Defined areas (SAFETY ZONES) are set aside where members may clean or repair guns or show them to another person.
- Guns may only be removed from holsters, boxes or gun bags in a designated Safety Zone area, on a live range under direction of an RO, or Committee approved situations e.g., training course or presentations.

- All shooting undertaken by visitors must be directly supervised by a Christchurch Pistol Club member standing within a reasonable distance to the shooter to maintain control.
- Where a Safety zone has been declared, firearms may be cleaned, repaired or tested by cycling or dry firing ONLY in this zone. Ammunition or anything resembling ammunition including dummy or drill rounds is **NOT PERMITTED TO BE HANDLED in any Safety zone UNDER ANY CIRCUMSTANCES.**

### **13. New Ammunition Use:**

If a new type of ammunition is proposed for use on the range, it must be approved for use by the SRO if considered safe to do so. Before inclusion in the RSOs, the requirements of section 34 of these orders are to be adhered to.

### **PROHIBITED AMMUNITION**

- The following ammunition must NOT be used on any range administered by the Christchurch Pistol Club Inc.
  - Air pistols pellets containing steel / copper / tungsten inserts.
  - Shotgun steel shot ammunition.
  - Any shotgun ammunition below number 5 lead shot.
  - Shotgun Buckshot and shotgun solid slugs.

### **14. TARGETS / NEW TARGET SYSTEMS:**

- Standard target centre height is 1.2-1.5 metres off the floor of the range.
- All soft targets set up range from the bullet catcher are to be set at a height so that fired rounds are captured by the centre of the bullet catcher or mobile bullet catchers are to be used.
- Targets are not to be placed above the line of sight from the standing position on the designated firing point nor should they be placed to cause divergent ricochets.
- On Ranges with earth side backstops, live fire may be directed into either the left or right-side backstops out to a maximum of 20 metres. There must be a backstop height of no less than 4 metres. Target placement must be carefully considered with target centre height being no greater than 1200mm.
- The RO officiating ensures that the target system is set so that no projectiles can escape the approved range template or the approved cone of fire for the target or targets.



## **IMPORTANT NOTE:**

- All range users are to ensure that in the interests of safety targets are placed as close as possible to the approved backstop in an effort to reduce the possibility of ricochets

## **15. Steel Plate Targets:**

- ONLY Approved steel plate targets may be used on the Christchurch Pistol Club Ranges. □ The minimum grade is Bisloy grade 450 or higher. (Refer to PNZ Steel Target Safe Use Guide).
- All steel targets to be approved by the RO Prior to use.
- All non-reactive steel plate targets to be set at a forward sloping angle of 15 Deg from the vertical to reduce the possibility of ricochets.
- All steel targets are to be shrouded if not under an eyebrow (Eyebrow are on Ranges 1-4, 6 & 9).

## **16. Moving Targets:**

- A moving target is approved for range 7 & 8.

## **17. Minimum safe engagement distances:**

- The MINIMUM distance permitted for engaging a steel target is as list in competition rules and the PNZ Steel target safe use guide:
  - 7 metres IPSC Handgun.
  - 7 metres IPSC Pistol Carbine/IPSC Mini Rifle.
  - 8 metres IPSC Shotgun (No. 5 to 9 shot only)
  - 5 metres CAS Pistol.
  - 7 metres CAS Shotgun.
  - 13 metres CAS Rifle.
  - 7 metres NRA pistol.
- Under no circumstances are shotguns using steel shot to be used on steel plate targets.

**Dropped out 50m IPSC rifle, 50m IPSC Shotgun solids,**

## **18. Eye and Hearing Protection:**

- All members and visitors to the club are to wear eye and hearing protection at all times while shooting is taking place with the exception of within the clubhouse and carpark. • Hearing protection is not required on Range 10.

## **19. Medical:**

- Medical kit is located in the club rooms and first aid kits are available at the Armoury, and one ranges 3, 5 – 9.
- Address to the nearest medical facility: Case brook Surgery 5/118a Claridge Rd Christchurch 805. Phone 03 359 4549.
- In a Medical Emergency Dial 111 and ask for Ambulance Assistance. (There is cell phone coverage at the club rooms.)
- **Address: 599 McLeans Island Road, Christchurch, 8051**

- Should this be necessary, send a person to the gate to guide the ambulance to the site.

## **20. Accident/incident procedure:**

- **Accidents not involving a Firearm: The following procedure is to occur:**
  - Cease Firing
  - Ensure the scene/situation is safe for all participants.
  - Render immediate first aid and assess the need for evacuation of the casualty to the nearest medical facility or onsite recovery by emergency services.
  - Notify the club President.
- **Accidents involving a firearm;**
  - Cease Firing.
  - Ensure the scene/situation is safe for all participants.
  - Render immediate first aid and assess the need for evacuation of the casualty to the nearest medical facility or onsite recovery by emergency services.
  - Make no attempt to remove or strip the firearm.

- Notify the Police. (This is a legal requirement).
- Advise the Club President or Secretary.
- Advise Executive Officer Pistol New Zealand.

**NOTE:** It is important that all users are aware of sect-20 Accident procedures and fully comply with this procedure in the case of any accident involving a firearm.

## **21. Fire Precautions and Procedures:**

- A fire permit must be obtained from the local authority before any fire is contemplated.
- All precautions are to be taken to reduce the possibility of fire in buildings and the surrounding grounds.
- In the case of fire Dial 111 and ask for Fire Brigade Assistance.
- **Address; 599 McLeans Island Road, Christchurch, 8051**
- Should this be necessary, send a person to the gate to guide the emergency service to the site.

## **22. Range clearance:**

- All users are to ensure that all range rubbish, including used targets, ammunition boxes, cartridge and shotgun casings and wadding etc, is removed from the range and placed in the main rubbish bin.
- Rubbish is not to be left on the range as it can easily become a fire hazard.

## **23. Unauthorised access and/or use of the range;**

- Any Individual or organisation given use of the Range Complex will have been provided with written authority from the Club.  
Any individual or Organisation unable to provide this approval as proof of authority must be asked to leave the property immediately.

Any refusal to leave should be reported to the Police as soon as possible.

## **24. Cone of Fire (CofF) Pistol / Rifle:**

The range design cone of fire for these ranges are;

**Rifle 20mils (1.125 degrees)**

**NOTE: The RO must be satisfied that a shooter has demonstrated their ability to achieve the approved CofF. (This may be from competition results or sighting in).**

## **25. Inability of the Shooter to Achieve the CofF:**

- If for any reason any shots fired fall outside the CofF the following procedure is to occur. □  
The RO is to:
  - Halt all firing and identify the shooter responsible.
  - Observe that shooters next shot and if it falls within the CofF allow that shooter to continue shooting.
  - If the observed shot does not fall within the CofF, the shooter is to be provided with a suitable coach with the intention of bringing the next round within the CofF. • Shooters who are unable to achieve the CofF are to be prevented from further firing. Shooters prevented from firing in this way may resume firing following the completion of a club approved training program with the firearm.

## **26. Unlicensed or Inexperienced Shooters:**

- Unlicensed/inexperienced shooters must be managed one to one by a member. •  
They are to be shown the safety aspects of using a firearm initially with an unloaded firearm.

- The RO is to determine the level of supervision required.

## **27. Test Firing:**

- Test firing of new firearms types or new ammunition types, can only be done with the approval of the committee of the Christchurch Pistol Club Inc. and conducted under the direction of a RO.
- A target must be used to ensure that so that all shots fall within the confines of the bullet catcher.

## **28. Air danger height (ADH):**

- The ranges are approved as a No Danger Area Range (NDA). As such there is no air danger height.
- All members and range users must be made aware that if an aircraft is seen to be approaching the club in a manner that may see them fly over the club property at a low level whilst live firing is in progress, the RO must immediately call for a 'stop' to all shooting until the aircraft clears the area.

## **29. Range maintenance plan:**

- The Christchurch Pistol Club Inc. Committee will schedule regular working bees to ensure that the range is kept to the required standard.
- The Bullet catchers are to be kept above the minimum angle.
- All unused targets are to be taken off the range when not in use.
- Steel targets that are pitted are to be removed from the range.
- The range bullet catchers must be in a safe serviceable condition before

shooting commences.

- Any drums used for mobile bullet catchers, excessively damaged must be removed from the range and reported to the Club committee to arrange replacement.
- Drums used as mobile bullet catchers must be filled with approved material (i.e., rubber chip, rubber belt etc).

## **30. Children (minors):**

- All children are to be under the direct supervision of an adult at all times. • All people under the age of 16 (sixteen) years are to be under the direct supervision of an adult older than 18 (eighteen) years at all times.
- Special attention must be paid to eye and ear protection.

## **31. Health and hygiene:**

- The club has toilet facilities. Users are to ensure these facilities are kept clean & tidy.
- Should any club member be ill or infectious please use standard measures such as

distancing or remaining home to avoid sharing it with others at the club.

- Be mindful of lead exposure and always wash hands when you finish shooting and particularly before handling food. Parents should ensure children do likewise.

### **32. Domestic animals:**

- Domestic animals are only allowed with the approval of the landowner and RO, must be on a leash at all times.

### **34. Amendment to RSOs:**

Proposals to amend the RSOs are to be forwarded to the SRO. The SRO is to consider the amendment and accept or decline the proposal. If declined, the SRO is to advise the originator accordingly. If accepted, the SRO is to submit the proposal to the Clubs and Ranges Team at Te Tari Pūreke - Firearms Safety Authority. The Clubs and Ranges Team will review the proposal, consult with the SRO where necessary, and either approve or disapprove the amendment. If approved, the SRO can then include the amendment in the RSOs with a new effective date, provide a copy to the Clubs and Ranges Team, and distribute accordingly. All previous copies of the RSOs are no longer valid.

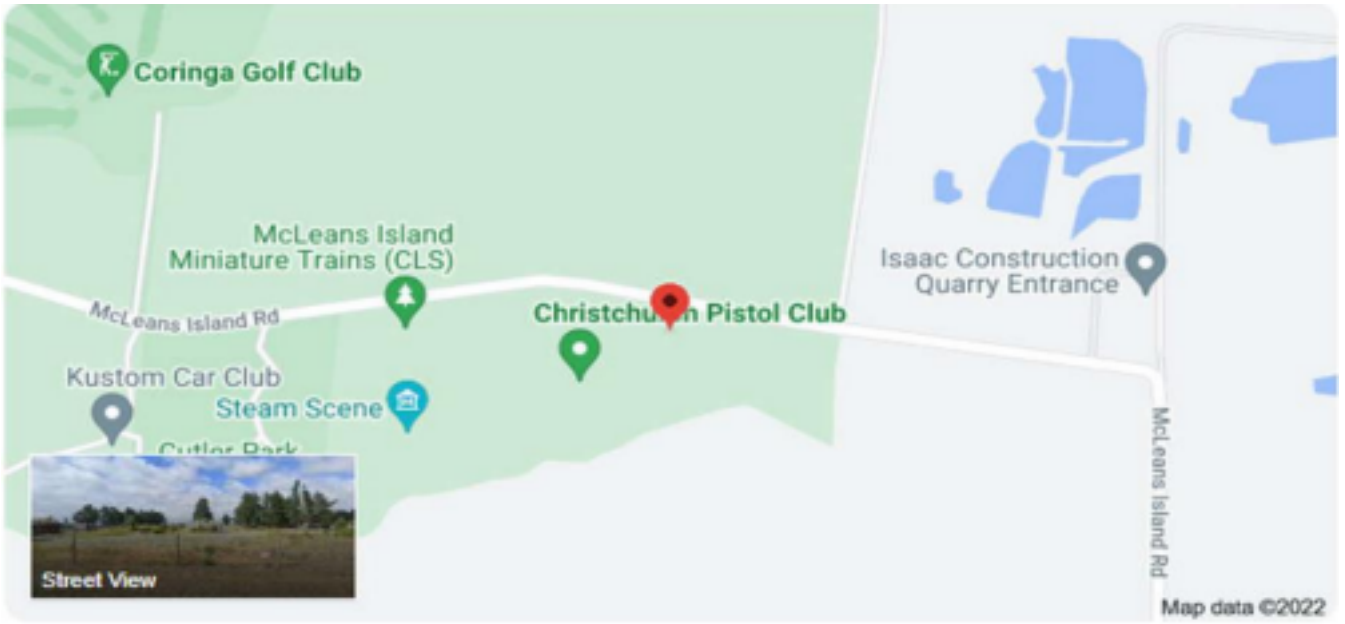
